

Old Business:	Event takes 10 days for color run donations to close out on the website and we get a check. Full amount will be known by next meeting. Donna seeked out donation to pay for athletic uniforms, raised \$5,500 and money was put in foundation bank account, please approve for Brain to write a check so we can pay JD print and apparel to make the uniforms. This is half of the amount that is needed and Redwood Empire will cover us the rest of the amount until the Foundation pays it. This will be debt if we proceed until we finalize the invoice. If we can't fundraise for it, the foundation pays for it. Girls basketball, track and girls volleyball has already received the uniforms 3 weeks ago, receiving the majority of the uniforms already without us paying yet because of strong relationship with JD. Pat motions we cut the check for \$5,500 and foundation takes on the responsibility of the rest and Brian seconds, all approved. Brian asks if we are collecting a deposit in case uniforms get damaged, there is no deposit or contract with Athletic Director to pay for these. Are the uniforms property of the school or Foundations? Andrea comments that we had an email going to the director that athletes signed a contract to take care of the uniforms and she agreed that it would be a great idea and families need to be responsible for damaged, we need to remind our director that a contract needs to happen ASAP and make families liable. Pat would like that to be differentiated between worn vs. lost so kids aren't responsible for typical wear. Just like the library and chromebooks, families know they are responsible for payment of replacement. The foundation is committed to uniforms so we move forward and buy extra stock and know that we own it. Georgia doesn't want to see so much foundations money and attention focusing on middle school programs. Majority of fundraising happens at younger age, we need to make sure its spread out with the attention and money. Brian wants to see the board discuss more broader the entire schools enrichme
